Answer 170:	The Bidders shall describe as part of form TECH-2 Method Statement (Section IV Bid Submission Forms of IFB) its approach to risk management, including identification of specific risks the Bidder has identified for this project and associated mitigation measures, e.g. measures to mitigate risks to safety within the limit of Site and surrounding areas. The Bidder's approach to risk management shall promote sound environmental and social performance, and improve implementation of the MCC Environmental Guidelines. The approach will be further detailed following contract award in the contractor's Construction Risk Management Programme and other documents, e.g. site-specific Health and Safety Management Plan ("HSMP"), including a COVID-19 Risk Mitigation Plan which establishes MCC's requirements to minimize the risk of COVID-19 at the contractor's work Site.
Question 171:	Is there someone I can talk with regarding learning how to answer a bid? One of the dilemmas was paragraph (e) of TECH-1 - method of statement - did you mean that I will write according to appendix D Mongolia II – Bulk water Supply Expansion CCP-1 ESMP? e) Description of approach to risk management included in the Bid, including identification of specific risks the bidder has identified for this project and associated mitigation measures.
