



## MINUTES OF PUBLIC BID OPENING

### PROCUREMENT OF CONSTRUCTION WORKS OF GROUNDWATER WELLS AND CONVEYANCE

PUBLIC BID OPENING HELD ON NOVEMBER 09, 2021 AT 10:30 AM ULAANBAATAR TIME (GMT+8), MONGOLIA

#### A. Participants

Three (3) representatives from the Bidders participated in the Public Bid Opening, together with representatives from MCA-Mongolia, MCC and the Program Management Consultant. The Bid Opening was an online event conducted on Zoom software and was organized by the Procurement Agent of MCA-Mongolia.

#### B. Introductions & Remarks

The Public Bid Opening commenced at 10:30 am, Ulaanbaatar time. The Senior Procurement Specialist of the Procurement Agent, Mr. Keith Treviss, briefly explained the process of the Bid Opening and invited MCA-Mongolia's CEO, Mrs. Sodontogos Erdenetsogt to provide opening remarks. Mrs. Sodontogos Erdenetsogt welcomed and thanked participants for attending the Public Bid Opening for the subject procurement, remarked the importance of this assignment, and handed the floor back to the Procurement Agent for the opening of the Bids.

#### C. Opening of the Bids

The Procurement Agent's Senior Procurement Specialist, Mr. Keith Treviss opened the Bids in order of their submission.

#### D. Proceedings

The Procurement Agent proceeded to open the Bids of all two (2) Bidders who submitted their Bids before the submission deadline and called out the name and country of the Bidder, currency and the amount of each Bid, and verified that (i) The Letter of Bid was included in the Bid and was signed, (ii) the Letter of Bid indicated the 180-day Bid Validity Period, and (iii) a Bid Security and (iv) a BOQ were included in the bid.
