Question 1:	Are the results of following two announced procurements, interlinked or not:
	 "Consultancy Services for Water Utilities Consumer Database Population and Systems Development" (RQI # MCA-M/CF/WSSA/CS/09) and; "Consulting Services for Development of Water Utilities Consumer Services Digital Platform" (RQI # MCA-M/CF/WSSA/CS/10)?
Answer 1:	Yes, as indicated under the sub-chapter titled Phase 2.1 "General systems structure and core functionality requirements of the water utilities consumer database system" of the Terms of Reference: "The key elements for the design sketch shall include data structure, user interface, security protocols, and plan for integrating the "Consumer Database System" with the "Water Utilities Consumer Services Digital Platforms". MCA-Mongolia plans to start the development of the "Water Utilities Consumer Services Digital Platforms" simultaneously with the "Consumer Database System" development. Therefore, it is important for the two consultants to ensure the plans are consistent with each other.
	However, please note that the detailed description of the required services is indicated in the Terms of Reference. The selected Consultant will be required provide the services according to the requirements of the Terms of Reference.
