In accordance with ITB 8.7 of Section II of the Bidding Documents, the Employer received Executive Summaries for proposed innovative concepts and held meetings in accordance with items 4 to 9 of Annex A of Section II of the Bidding Documents.

As set forth in ITB 9.1 of Section II of the Bidding Documents, the following summary describes the rejected innovated concepts. Bids based on rejected innovative concept will be considered not substantially responsive.

- **The use of membrane aerated bioreactor (MABR) in place of MBBR,**
- **The use of circular clari-floculators with a lower surface loading rate in lieu of lamella clarifiers with a higher surface loading rate.**

Since the Employer did not accept any submitted innovative concepts, the following changes to ITB 9.1 of Section II of the Bidding Documents shall apply:
