Webinar on Planned Works Procurements of MCA-Mongolia under the Downstream Wells Activity

Date: June 12, 2020

I. INTRODUCTION

The United States of America, acting through the Millennium Challenge Corporation and the Government of Mongolia have entered into a Millennium Challenge Compact for Millennium Challenge Account assistance in the amount of 350 million USD to help facilitate poverty reduction through economic growth in Mongolia (the “Compact”).

The webinar was organized by Millennium Challenge Account-Mongolia (“MCA-Mongolia”), an accountable entity established to oversee the implementation of the Compact and was intended to provide interested bidders the information on the Water Supply Project and procurement opportunities under the project.

The entire webinar session was conducted as an online event, using Zoom software.

- **Mrs. Enkhtungalag Togtokh** made a presentation on the procurement procedures of MCC funded projects by briefly overviewing the upcoming works procurements of MCA-Mongolia and informing participants on how to obtain publicly available information and documents related to MCA-Mongolia's procurements;
- **Mr. Bayar Purevdorj** made a presentation on the tax regulations for international and local contractors of MCA-Mongolia.
