



## **MINUTES OF PUBLIC BID OPENING**

### **FOR THE PROCUREMENT OF THE WASTEWATER RECYCLING PLANT DESIGN-BUILD**

**CONTRACT NUMBER: MCA-M/CF/WRA/W-01**

**PUBLIC BID OPENING HELD ON FEBRUARY 16, 2022 AT 10:30 AM ULAANBAATAR TIME (GMT+8), MONGOLIA**

#### **A. Participants**

Representatives from two (2) Bidders participated in the Public Bid Opening, together with representatives from MCA-Mongolia, MCC and the Program Management Consultant. The Bid Opening was an online event conducted on Zoom software and was organized by the Procurement Agent of MCA-Mongolia.

#### **B. Introductions & Remarks**

The Public Bid Opening commenced at 10:30 am, Ulaanbaatar time. The Procurement Agent Manager, Mr. Colin Coyle, briefly explained the process of the Bid Opening and invited MCA-Mongolia's CEO, Mrs. Sodontogos Erdenetsogt to provide opening remarks. Mrs. Sodontogos Erdenetsogt welcomed and thanked participants for attending the Public Bid Opening for the subject procurement, remarked the importance of this assignment, and handed the floor back to the Procurement Agent for the opening of the Bids.

#### **C. Opening of the Bids**

The Procurement Agent's Senior Procurement Specialist, Mr. Keith Treviss opened the Bids in order of their submission.

#### **D. Proceedings**

The Procurement Agent proceeded to open the Bids of all three (3) Bidders who submitted their Bids before the submission deadline. The PA called out the name and country of the Bidder, currency and the amount of each Bid, as well as the number of days for completion, calculated from the Commencement Date to Issuance of Taking-Over Certificate. One Bidder did not submit their proposed Time for Completion. PA verified that (i) The Letter of Bid was included in the Bid and was signed, (ii) all Bidders met the Bid Validity Period, (iii) a Bid Security; were included in the bid.

**E. Closing**

After opening of the Bids, the Procurement Agent informed participants that Minutes of the Bid Opening, together with a Bid Opening Checklist, would be sent to all participants via email for their records.

The CEO of MCA-Mongolia thanked participants for their participation and closed the Public Bid Opening Session at 10:40 am, Ulaanbaatar time.
