Question 10:	With regard to local permission for international contractors - do they need to have it?
Answer 10:	Clauses 45.2 and 45.3 of the Law of Mongolia on Construction provide two options for Foreign individuals and legal entities (Foreign Contractors) to consider:
	i. Clause 45.2 states "A foreign legal entity in order to carry out construction activities shall obtain a license as set forth in the clauses 19 and 20 of this law."
	ii. Clause 45.3 states: "Unless otherwise specified in the legislation of Mongolia, the foreign entities to perform the construction activities to be funded from the state or local state budget or funded by the foreign aid or loan shall perform the activities in cooperation with the authorized Mongolian legal entity through entering into a contract as provided in this law

Our company is recognized one of best public enterprise in (names of Enterprise and Country removed for confidentiality reasons) but we have established based on commercial law as an Incorporated company (Co Ltd).
